Submission process:

- Closing date for the submission of abstracts: Tuesday, May 31, 2016, 11:59 p.m.
- All applicants will be notified of the outcome in July 2016
- All submissions must be made electronically via email as Word for Windows-format to info@physio-deutschland.de
- Abstracts can be submitted either in German or English
- Submitted abstracts will go through a blinded peer-review process carried out by interdisciplinary reviewers.

Poster content:

- Ongoing as well as completed projects with clear reference to physiotherapy.
- Also physiotherapy projects based on bachelor or master-, or doctoral theses.

Poster presentations:

Posters and presentations can be either in German or English.

Posters are reports summarising information using brief written statements and graphic materials, such as graphs, charts, figures and photographs mounted on a poster board, the dimensions of which must not exceed the allocated space per poster (this will be notified at the time of acceptance)

Posters will be on display for one day during the posterforum.

The time allocated by the moderator to presenters of the posterforum will be notified at the time of acceptance.

Presenters assigned by the congress organizer for a poster session in the Poster Forum can attend all conference sessions (except workshops) free of charge.

The following criteria will be used to review the abstracts:

- Purpose and questions: Are the contents of the abstract clear and intelligible?
- Does the report address a significant issue as regards professionalization and/or development of physiotherapy and/or evidence base?
- Are methods and results clearly stated and adequate for the questions pursued by the project?
- Have ethical aspects, e.g. patient and data safety adequately been taken into account?
- Have the data/findings been interpreted appropriately and also been critically reflected upon?
- Did the author/s use current literature?
- The reviewers will also make an overall assessment.

Abstracts may not exceed a maximum length of 3.000 characters (incl. spaces).		
Structure using the following headings:		
Title, Purpose, Methods, Results		
The three most important literature references.		
Selection through a process of anonymous peer reviews: The names of authors or of their institution shall not be mentioned in the submitted abstract.		
The author agrees that her/his poster shall be presented on a display during the posterforum Saturday, October 22, 2016, 14.30 – 16.15 p.m. at the BUNDESKONGRESS PHYSIOTHERAPIE, in the Radisson Blu Park Hotel & Conference Centre, Dresden		
It is assumed that if there is more than one author, the author presenting the poster at the congress has the authorization of his co-authors to do so.
